**SECTION 7. HANDLING AND STORAGE**

- Advice on protection against fire and explosion : Take necessary action to avoid static electricity discharge (which might cause ignition of organic vapours). 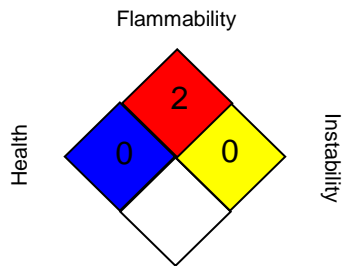
